#### Sixth Day Enrollment Report | 2020-2021

As of September 9, 2020, AHSD25 serviced a total of 5,362 students. The overall early childhood – eighth-grade student enrollment is down 221 students compared to the sixth-day enrollment from the previous school year (5,452). The current enrollment falls slightly above the projected enrollment for this year and within the 5-year projected enrollment study that was done in December 2018.
