All student fees were proposed to remain the same, except the following:

- 1) **Transportation:** District 25's transportation contract extension with Cook Illinois reflects a 3% increase for 2019-20. Based on this, District 25 is recommending an increase in the transportation fee from \$400/year to \$412/year. This fee is paid only by families that don't qualify for free transportation, but wish to pay for transportation, and there is a route with availability already going through their residential area.
- 2) **Children's Circle Tuition:** District 25 is proposing an increase in the tuition fee for the early childhood Children's Circle program from \$290/month to \$320/month (for 10 months) based on the actual cost of the program for typical students. District 25 hasn't increased this fee in three (3) years.
- 3) **Calculators (TI-15; 4th grade advanced & 5th grade):** The proposed fee increase for these calculators is \$2, from \$14/year to \$16/ year.
- 4) **Calculators (TI-34; Middle School):** The proposed fee increase for these calculators is \$3, from \$16/year to \$19/year.
- 5) **Graduation:** The proposed fee increase for the 8th grade graduation gown and diploma/ribbons/etc is \$1.50+, from \$29.00+ to \$30.50+.
