# TAKING ACTION

## Department of Facilities Management

2yr Renewal of Grass
Cutting and Shrub
Trimming Contract
\*APPROVED\*

Gilio Landscaping was awarded a 3yr grass cutting and shrub trimming contract in the spring of 2016. This included the option to award an additional 2 years of service if they met the requirements set forth in their contract and meet the District's landscaping needs. Based on their past service, we recommend their contract be extended for the 2019 and 2020 growing seasons.

Site Work and Concrete improvements \*APPROVED\*

The intended award includes scope related to site preparation, curbs and drainage for the Patton playground replacement project. In addition, this scope includes replacement of the Dryden Elementary School asphalt playground surface and site concrete repairs at Dryden, Dunton and Miner. Several drainage improvements will be completed at Rand School and Miner to repair failing storm sewer systems.

Roofing Repair and Restoration Improvements \*APPROVED\*

This bid package is for restoring the metal roofing at South Middle School over the commons and gymnasium. These roofs have seen repeated leaks over the past several years that need continued maintenance. This restoration coating will restore the integrity of the roofing to provide a watertight system. In addition, a section of roofing over the Windsor LMC will be replaced.

Flooring replacement scope to Vortex
Commercial Flooring
\*APPROVED\*

This flooring replacement package is to replace poor flooring across multiple buildings in District 25. Annually flooring is assessed based on its current condition and logged into the Facilities asset tracking program to determine when it is due for replacement. This year, replacements are slated for South Middle School, Olive-Mary Stitt, Westgate, Ivy Hill, Patton, Thomas Middle School and Windsor.

Structural and Miscellaneous Steel Improvements scope \*APPROVED\* This award package is to improve stairway, ramp and other guardrails to be compliant with current code standards. Several of the handrails and guardrails are not compliant with new standards for the size of openings and locations of the handrail grab heights. This package will replace and modify handrails and guardrails to bring them into compliance at several buildings. In addition, this package will include reinforcement to the rear of the Olive stage wall to compensate for a crack that has occurred where the 1960's building meets the commons addition that was installed in the mid-1990's.

Annual Recommendations for Personnel Releases \*APPROVED\*

Each winter the school district analyzes its staffing plans based on student enrollment projections, program needs, mandated state programming, student identified needs, and the goals of the district. We do our best to forecast the needs of our staff members and to make decisions that will ensure that our school district is fiscally responsible. Since we are still putting our staffing plans together and evaluating our student enrollment, we are asking that the Board of Education take action on the Resolution and honorably discharge the 12 group one staff members this evening pursuant to Section 24-12 of the School Code.
