Every year District 25's Department of Business and Finance prepares a budget for the upcoming school year which includes a look at District 25's future finances and projections. That budget was presented at this board meeting. By law the tentative budget must be available for public inspection for at least 30 days prior to adoption by the Board of Education. The calendar is below as legally required:

- August 15, 2019 - Presentation of 2019-20 tentative budget
- August 16, 2019 - Publish notice (in local paper) for public hearing
- September 19, 2019 - Public Hearing
- September 19, 2019 - Potential of adoption of the final budget

Presentation highlights:
