Last month Assistant Superintendent for Business/CSBO, Stacey Mallek, presented a tentative budget which includes a look at District 25's future finances and projections. By law the tentative budget was available for public inspection for at least 30 days prior to possible adoption by the Board of Education.

Approval highlights:

- The revenues increased by \$196,000 and the expenditures decreased by \$345,000 between the tentative and the final budget.

Enrollment Report, Sixth Day - Visit www.sd25.org/BOEMeeting for this presentation from the Board Meeting.

Our Department of Personnel & Planning is constantly monitoring and studying District 25's enrollment with a strong focus on keeping class size numbers as low as possible, while still being fiscally responsible.

As of August 29, 2019, AHSD25 serviced a total of 5,583 students. The overall early childhood – eighth-grade student enrollment is down slightly, 24 students, compared to the sixth-day enrollment from the previous school year (5,607). This slight decrease is something the District had anticipated.
