- Must be suitable for use in high-speed production copiers, standard copiers and laser printers.
- Paper shall be free from lint wrinkles, waviness, folds, holes, tears, wrapper glue, damaged edges, and any scrapes of foreign materials and or other defects.

Vendor will bid on an approximate total of 2,000 (+/-) cases of white multipurpose copy paper.

All discounts must be reflected in net bid price. All prices must include shipping and delivery costs. No bid showing a cash discount from total price will be considered.

DELIVERY: All paper will be delivered on an as needed basis to ten (10) locations.

Price per case should be effective for the entire 2024-2025 School Year (07/01/2024 - 06/30/2025).

Arlington Heights School District 25 is exempt from Federal, State and Municipal Taxes.

INSTRUCTIONS TO BIDDER

Bid Forms

Bid must be submitted on the form provided. One Copy is for bidder's file. Envelopes must be marked "Sealed Bid for (whatever commodity is being bid)".

Specifications

Generally, where specifications indicate a particular brand or manufacturer's catalog number, it shall be understood to mean that or equal, unless "no substitute" is specified. When offering alternates, they must be identified by brand name and catalog number, and manufacturer's literature must be included.

Samples

Bidders will be required to furnish no charge samples upon request.

F.O.B. Point

All Prices <u>MUST BE QUOTED F.O.B. DESTINATION.</u> Shipments shall become property of consignee after delivery and acceptance.

Delivery Points

Deliveries will be to the various buildings within District 25, as indicated. There are no loading docks at any of the buildings.

Delivery Schedule

Bids must specify delivery time. Unrealistically short or long delivery promises may cause bid to be disregarded. Order may be canceled without obligation if delivery requirements are not met.

Evaluations

The Board of Education reserves the right to reject any and all bids, to waive any technicalities in the bidding and to award each item to different bidders or all items to a single bidder unless otherwise noted on bid request, and to determine whether in the opinion of the Board of Education: (1) an equal or alternate is a satisfactory substitute, (2) an early delivery date is entitled to more consideration than price, (3) an earlier delivery date is to be disregarded because of the reputation of the bidder for not meeting delivery dates, (4) a bidder is not a responsible bidder and should be disregarded, and (5) what exceptions or deviations from written specifications will be accepted.

Prices

Prices, terms, and conditions <u>must be firm for the entire school year, which runs from July to June</u> unless otherwise agreed to by District 25 and bidder.

Quantities

When so indicated, <u>quantities shown may be estimates only</u> and <u>orders may be more or less</u> depending on actual requirements.

Exceptions

Any exceptions to these terms or conditions or deviations from written specifications must be shown in writing and attached to the bid form.

Tax Exemptions

Arlington Heights School District 25 is exempt from Federal, State, and Municipal taxes. Exemption certificates may be furnished upon request.

Criminal Code

The contractor/vendor certifies that it is not barred from bidding on the contract as a result of a conviction for either bid rigging or bid rigging or bid rotating under Article 33E of the Criminal Code of 1961 as amended.
