Food Service Equipment Bid Form - Patton

1. What size table are you looking for? If you would please provide length and width.
 - Item #5 - [16 GA Stainless Steel Top Work Table 72" x 30"D, 4 ½"H backsplash](#), Stainless Steel Legs, and adjustable undershelf. Adjustable Stainless feet
2. Need depth of worktable you require 24", 30" 36" deep?
 - Item #5 - [16 GA Stainless Steel Top Work Table 72" x 30"D, 4 ½"H backsplash](#), Stainless Steel Legs, and adjustable undershelf. Adjustable Stainless feet
3. Why do some of the Randell units request elementary height and others do not?
 - The hot serving unit should be the only unit at standard height, with the tray slide being at elementary height on the service side.
4. The hot food table are you looking to put a heat lamp on the unit, and do you want it to be 48" long like a hatco heat lamp to be shipped to Randell for install? Randell is not providing a heat lamp.
 - We removed the following specification (HLINST-HL Heat Lamp, by others, installation charge), as we will not need a heat lamp on the unit. Please see the revised specs.
5. Item 10 cashier counter you want the tray slide on the server's side please verify.
 - Tray slide should be on both sides, see the revised specs.
6. My only question for clarification is the submittal it says sealed envelope and delivered and received to the stated address, does that mean hand delivered or can it be mailed as long as it gets there by the appropriate time?
 - Submittal does not need to be hand delivered, they can be mailed as long as they are received by the submittal date.
7. Are you able to provide any drawings for this?
 - Yes, please see updated drawing links on the revised bid form.

8. Please note that the specs on Item #8 of the Patton Elementary list excludes the RSHGTMOD Elementary Counter, school height (30-1/2" work height).
 - No, the unit specified should be furnished at standard height
9. For delivery at any of the schools, can you provide the information below (Patton)?
 - Are there stairs or steps that the movers will need to use to move the equipment to the room?
 - i. No, there are no stairs or steps
 - Do you need to dispose of or swap any current equipment?
 - i. No, there is no disposal or swapping of equipment

1. The care cartridges do you want a total quantity of 4 which would supply each unit with 1 of each?
 - Correct, there are 6 cartridges per box. So I am requesting a total of 1 box per unit.

 - Yes, two combi units are to be delivered and installed to each school.
3. For delivery at any of the schools, can you provide the information below (South & Thoma)?
 - Are there stairs or steps that the movers will need to use to move the equipment to the room?
 - i. No, there are no stairs or steps
 - Do you need to dispose of or swap any current equipment?
 - i. Yes, the installers will be required to remove the existing gas convection ovens from the installation space and roll to the dock area. There is no disposal necessary.
