

**Arlington Heights School District 25
Illinois Prevailing Wage Resolution
2018-19 Fiscal Year**

WHEREAS, the State of Illinois has enacted the Prevailing Wage Act approved June 26, 1941, as amended, being Chapter 820 ILCS 130/1-12, Illinois Compiled Statutes; and

WHEREAS, the aforesaid Act requires that Arlington Heights School District 25, Cook County, Illinois investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Arlington Heights School District 25 employed in performing construction of public works, for said Arlington Heights School District 25; and

Now, therefore, be it resolved by the Board of Education of Arlington Heights School District 25, Cook County, Illinois, as follows:

SECTION 1: To the extent and as required by the Prevailing Wage Act, the general prevailing rates of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Arlington Heights School District 25 is hereby ascertained to be the same as the prevailing rates of wages for construction work in the Cook County area, as determined by the Department of Labor of the State of Illinois as of September 1, 2017, a copy of that determination being attached hereto and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rates of wages by the Department of Labor of the State of Illinois shall supersede the Department's June determination and apply to any and all public works construction undertaken by Arlington Heights School District 25. The definition of any terms appearing in this Resolution which are also used in aforesaid Act shall be the same as in said Act.

SECTION 2: Nothing herein contained shall be construed to apply said general prevailing rates of wages as herein ascertained to any work or employment except public works construction of the Arlington Heights School District 25 to the extent required by the aforesaid Act.

SECTION 3: The Arlington Heights School District 25 Clerk or Secretary shall publicly post or keep available for inspection by any interested party in the main office of Arlington Heights School District 25 this determination or any revisions of such prevailing rate of wage. A copy of the determination or of the current revised determination of the prevailing rates of wages then in effect shall be attached to all contract specifications.

SECTION 4: The Arlington Heights School District 25 Clerk or Secretary shall mail a copy of this determination to any employer and to any association of employers and to any person or association of employees who have filed their names and addresses and have requested copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5: The Arlington Heights School District 25 Clerk or Secretary shall promptly file a certified copy of this Resolution with the Secretary of State of the State of Illinois.

SECTION 6: Arlington Heights School District 25 relies on the Prevailing Wage rate for Cook County determined by the Department of Labor. In accordance with the recent amendment to the Prevailing Wage Act, the Arlington Heights School District 25 Clerk or Secretary shall post a notice of the determination on it's website with a link to the prevailing wage schedule for the county.
