### School Board Hearing Minutes February 18, 2016

David Page, President of the Arlington Heights School District 25 Board of Education, called the hearing to order at 6:30 p.m. at South Middle School, 400 S. Highland Ave., Arlington Heights, Illinois, on Thursday, February 18, 2016. The hearing was held per Board Policy 8:30, Visitors To and Conduct On School Property.
