School Board Meeting Minutes
August 12, 2021

Scott Filipek, President of the Arlington Heights School District 25 Board of Education, called the meeting to order on August 12, 2021 to accept a motion to adjourn into closed session at 6:48 p.m. The meeting was held at the Dunton Administration Building, 1200 S. Dunton Avenue, Arlington Heights, Illinois.

Regular Meeting

Scott Filipek, President of the Arlington Heights School District 25 Board of Education, called the meeting to order 7:36 p.m. on August 12, 2021. The meeting was held at the Dunton Administration Building, 1200 S. Dunton Avenue, Arlington Heights, Illinois. Roll call was noted and the Pledge of Allegiance said.

Facilities Management

Resolution to Extend J. Adler Roofing Contract

Mr. Schulz noted that due to supply chain issues, the contractor for the Thomas roof is unable to procure a specialty fastener that is needed to properly secure a component of the roofing system to the existing roof deck. In consultation with the contractor, a roofing consultant, and in alignment with the roofing contract, we would like to grant a \$0 change order to the contract substantial completion until September 30, 2021. We are hoping to locate the fastener, so it may be able to be completed this fall. We are also requesting that the Board grant the Director of Facilities Management the authority to issue additional extensions to J. Adler roofing past the September 30 substantial completion date should the fasteners not become available.

A Board member asked for more specifics about the fastener, and Mr. Schulz explained that it is for gypsum-based deck that requires a specialty fastener.

Adler Roofing beyond 30 days and delegating limited authority to the Director of Facilities Management to grant further extensions should supply chain delays continue.

Business and Finance

Crossing Guard Locations for 2021-22

Ms. Mallek reviewed the crossing guard locations for 2021-2022, and explained that this is an annual item given to the Board for approval. The district performed school crossing location counts which did not result in any other recommended changes to crossing guard locations. Four locations remain unstaffed, and there are an additional three locations that have become vacant in the past few weeks. We are actively looking for staffing. The district works with the village to post crossing guard positions.

A Board member asked about adding signage if we cannot have a crossing guard at the location, and Ms. Mallek noted the district does not have the ability to add signage because crossing guards are the responsibility of the village. Anyone interested in the position can apply on the district website, or they can reach out to Laura Comastro, the Transportation Specialist for the district.

Serious Safety Hazard Resolution for 2021-22

Ms. Mallek stated that the School Code provides that districts annually review the conditions and certify to the State that the conditions remain unchanged. There are no changes from last year and the district has not received any requests for any new hazard locations.

Motion: A. Patel moved and C. Conley seconded the motion that the Board of Education approve the Resolution to Continue Serious Safety Hazard Busing for the 2021-22 school year.

Presentation of the 2021-22 Tentative Budget

Ms. Mallek presented information on the tentative budget for the 2021-2022 school year. She reviewed the budget assumptions, noting that revenue from property taxes is based on a 99% collection rate, and that the CPI was 2.3% in 2020 and is 1.4% in 2021. Interest income is 0.4%, which is down from 0.5%. There was an increase in the Evidence Based Funding from the state of \$129,892, and federal funds include the ESSER Emergency Relief Grant and the NSLP/Summer Food Service revenues. Building rentals revenue is being added back. The total revenue budget increase is \$4,761,047.

The expenditures were reviewed and Ms. Mallek explained that personnel costs are 79% of the budget, excluding debt and construction. Salaries are based on the current collective bargaining agreements and tied to CPI, and health insurance costs increased six percent. The budget includes \$ 1.3 million to support the Technology Plan, and no additional funds will be used for COVID. There will be an increase in Special Education tuition; an increase in food service food and supplies; an increase in the bus transportation contract; and an anticipated increase in the insurance premium. Contingency funds include five certified staff, six non-certified staff, \$100,000 non-staff in the Education Fund, and \$50,000 in the Capital Projects Fund.

Chad Conley left the meeting at 8:01 p.m. and returned at 8:02 p.m.

The fund balance is projected to drop below the 60% mark this year, and we will bring this to the board for discussion at a later date. We will continue to finalize and make changes to the budget, and the Board will vote on it at the September 23 meeting. The tentative budget will be posted on the district website and the notice for the public will be posted. Ms. Mallek shared the budget timeline in accordance with legal requirements.

Board members asked questions and there was discussion regarding life safety, and a decrease in the fund balance. Ms. Mallek noted that she will review the fund balance when she presents the five-year forecast. Keeping the fund balance at 60% was important when the property tax revenue was received late, and the district had bond payments. Within the past five to six years, the payments have been more on time, so the level is not needed. Ms. Mallek feels we could go lower, but it depends on where the Board would like it to be. Ms. Mallek was thanked for her presentation.

- NSSEO – Dr. Bein reported on behalf of Ms. Faso. Condolences were sent to the family of an 8th grade Miner School student who passed away unexpectedly. Timber Ridge gym construction continues and is moving along on schedule and on budget, and they are excited to welcome a new Assistant Principal to Miner School. Mr. Filipek also noted that there is an upcoming Special Olympics fundraiser with Dunkin Donuts and the police department.
- IASB – Ms. Patel reported that IASB offers online workshops; the Joint Annual Conference is coming up in November; and the Board may have the resolutions for the delegate assembly by next month.
- ED-RED –Mr. Olejniczak noted that the kickoff luncheon will be held on September 24, and talked about the town hall meeting that Senator Gillespie and Representative Walker held recently.
- Board Governance – Mr. Filipek read an excerpt from the Behavioral Expectations regarding sincere listening and seeking to understand the viewpoints of others.

They have held two council meetings, attended a virtual back to school event with other PTA leaders within the region, and have attended officer training courses. Throughout the school year, the PTA provides all children with meaningful experiences and programs, and the PTA shows their appreciation for staff in various ways. Please consider joining your school's PTA if you have not already done so.
- ABC25 – Dr. Bein reported on behalf of Ms. Faso. ABC25 will be opening grant applications next week and look forward to seeing all of the creative ideas that the staff will bring forward for consideration. ABC25 hopes that many families

had the opportunity to join the foundation during school registration but if not, to please consider joining.

- ATA – Ms. Berg reported that the luncheon that was held this afternoon with the new teachers, ATA, Ms. Patel, Mr. Cerniglia, and administrators was very positive. The ATA completed the MOU and was pleased to work with the representatives of the Board and administration, and noted that it was a collaborative effort with open and meaningful dialogue. The ATA is looking forward to collaborating this year. The teachers are thrilled to be starting the year in- person. She thanked the Board for their efforts.

Superintendent Report
2021-2022 School Year Update

Dr. Bein provided a report to the Board for the 2021-2022 school year. The district received a letter yesterday from the ISBE Superintendent regarding the new school year and the executive order, and noted that once an executive order is issued, it has the effect of law, and that non-compliance is not an option. School districts continue to get updated guidance. Executive order 2021-18 was explained. It requires the use of face coverings by those over the age of two, and the implementation of other layered prevention strategies to the greatest extent possible.

Close contact definitions as of August 2 were reviewed and included classroom exposure, indoor exposure, outdoor exposure, and vaccinated individuals. There are four quarantine options in schools: 14 days if non-vaccinated; 10 days if no symptoms present; if a negative PCR test taken on Day 6 or after their exposure, they could reduce the quarantine to 7 days; and the test to stay program. She explained the test to stay program in detail, and noted that to participate in the program, there are steps that must be followed.

Dr. Bein's recommendation to the Board includes opening school for full time instruction, aligning with all items in the current executive order, and communicating that flexibility continues to be important as health department guidance changes. Tomorrow a detailed Q&A booklet will go out to families and staff, which goes into more detail. The district will continue to update the document as we get new information.

Board members asked questions and there was detailed discussion regarding the governor's executive order; distancing; close contacts; lunch and recess; mask breaks; daily health screening; Shield testing; and vaccination clinics for students. The Board attorney, Ms. Sarah Boucek, answered several questions from Board members

including what gives the governor the power of law; the implications on the Board; insurance policies and liabilities; and future conversations if the mandate is lifted.

Board members thanked the Food Services Department for the incredible amount of work that they have done since March 2020 by providing food to the community each week in the cold, heat and weather. They served 994,000 meals. Dr. Bein was thanked for continuing to provide the Board all of the information to be able to understand all perspectives and make good decisions.

There was discussion on the motion and what happens when the governor's executive order is no longer mandated. The Board attorney recommended to proceed with the motion, which will give the Superintendent a clear path of what to do.

Patel seconded the motion that the Board of Education approve opening school for full-time instruction, align with all items in the current Executive Order from the Governor of Illinois, and communicate that flexibility continues to be important as health department guidance changes.

Approve the COVID-19 Testing Support Agreement with The Board of Trustee of the University of Illinois

Ms. Mallek noted that Shield testing is now free for all K-12 school districts. It is a screening tool for the COVID-19 virus in symptomatic, pre-symptomatic, and asymptomatic individuals. The agreement would allow us to move forward to set up the testing. They will come into our schools to do the testing. It will be an opt-in program, and families will need to complete a consent form. Testing would occur during the school day, and the results will be available in up to 24-hours, but typically less. Students that participate would not be subject to quarantine if they became a close contact. It helps reduce the possibility of students having to be out of school to quarantine.

Board members asked questions regarding testing and quarantining. This test has a 98.6% efficacy rate, and will give the district good data to see what is happening in our schools. The testing helps us keep students in school, which is the goal that we all have. The Board would like to get a status of how many students are participating.

Theresa Funk	<p>The note from Dr. Bein -- and the decision of the school board -- is confusing. Why are you referencing the CDC guidelines but also disregarding them? Was the decision made to intentionally ignore the CDC decision because of better data from a more reputable source? This week the American Academy for Pediatrics also issued guidance that strongly urged the use of masks for both teachers and students until a vaccine is available for children. Given that the large population of students in attendance do not qualify for a vaccine yet, will the Board reconsider their decision?</p> <p>I'm just seeking to understand what scientific information or data this decision was based on, given that it seems to ignore the official guidance from the CDC.</p>
steven andrews	<p>My children attend a D25 elementary school. Masks need to be mandated in schools, especially elementary schools with populations that are not yet eligible for the COVID-19 vaccine. Guidance from CDC, IDPH, and AAP clearly support this.</p> <p>CDC - Masks should be worn indoors by all individuals (age 2 and older) who are not fully vaccinated.</p> <p>IDPH - Masks should be worn indoors by all individuals (age 2 and older) who are not fully vaccinated.</p> <p>AAP - All students older than 2 years and all school staff should wear face masks at school (unless medical or developmental conditions prohibit use).</p> <p>The District's decision to ignore this guidance and make masking optional is absurd. We continue to see growth in covid-19 infections driven by the more contagious delta variant. Masking helps combat the virus and reduces the risk of infection among our student population, most of whom are not vaccinated and do not yet have the choice to be vaccinated. Masks do not protect the individual wearing the mask from the virus; Masks stop an individual with COVID-19 from spreading the virus throughout a community. Per guidance from AAP and CDC, masks should be required for in-school learning for unvaccinated individuals while indoors, anyone under 12 years of age. With limited social distancing inside a building, we need all that we can to ensure there is limited disruption in learning, should the disease spread in a classroom. We have had to follow up multiple times with requests for further clarification and explanation of summer programs and new policies for the 2021-2022 school year. In addition, the Board did not provide the community sufficient notice that an important decision/vote would be taking place for the July 2021 meeting. We expect the board to follow through with complete transparency and represent our community. We think that further information is warranted and should be communicated in writing to parents via mail and/or email regarding school lunch, recess, extracurriculars, quarantine procedures, and quarantine remote learning. Parents should have complete information so that they may choose to make the best decisions for their families.</p> <p>Specifically: Definition of Close Contact: The definition of "close contact" has changed for the 2021/2022 school year. Can parents request to be notified regardless of the universal masking policy, if their child was within 3 feet of a positive or probable case? What is the process in which they may do this? If a parent chooses to quarantine their child, will the child be able to access the remote option? Vaccination Records: So that all parents may understand, if they choose to submit their child's vaccination status, their children will no longer be a part of contact tracing. Are there any other implications? How else will the District use this information? Do parents have the option to opt-in to contact tracing for their child? What is the process in which they may do this? If a parent chooses to quarantine their child, will the child be able to access the remote option? Lunch: What safety precautions are being put in place for lunch this year? What distance will there be between students by school? Will students have the choice to eat outside, weather permitting? If parents choose to pick their children up for lunch each day, how can children be signed out? (I would think this information needs to be provided by school if the processes are different.) SHIELD: Will children enrolled in this program be eligible for contact tracing or is this similar to being vaccinated? Do parents have the option to opt-in to contact tracing for their child? What is the process in which they may do this? If a parent chooses to quarantine their child, will the child be able to access the remote option? "The Greatest Extent Possible": Distancing to the greatest extent possible, does not inspire confidence, and is subjective. As I understand, the greatest concern would be at the middle school levels in which classroom distancing could be as little as 1.5 feet. This needs to be clearly defined by school and by classroom. This also needs to be defined for extra curriculars. For example, the Summer and Concert will be held outdoors on August 12th. Clear communication to parents is necessary as "the greatest extent possible" is not clear. Thank you for your time and attention to detail in regards to all Covid-19 processes and procedures and their clear and thorough communication to District parents. Thomas Loch	<p>I am disappointed that I even need to write this comment: The priority of AHSD25 should be to provide a safe and healthy environment for its students, employees and their families. The district should do its part to stop the spread of Covid-19 and its variants—and taking unnecessary health risks in a pandemic is not acceptable.</p> <p>By ignoring the majority of public health professionals, the AHSD25 Superintendent and Board wanted to make masks optional in a pandemic during a variant surge while most students are still ineligible for vaccination—taking an unnecessary, perhaps even reckless, risk for no significant benefit. Thank goodness the governor stepped in to make the safer and better decision about masking for all Pre K–12 schools in the state.</p> <p>For the record, I support the opening of full-time, in-person instruction in schools, but the schools should be opened with safe procedures in place—which includes vaccination or testing of the unvaccinated among those currently eligible for vaccination, and the masking of everyone in the school and on a school bus.
