Olejniczak seconded that the Board of Education terminate the employment of Registered Nurse, Tory Eitz, effective immediately, due to gross misconduct committed outside the scope of her employment, multiple unauthorized violations of District 25 Policy and Procedures, and willful insubordination, as recommended by the Administration.

Mr. Scapillato read a statement. "The recent breach of trust by one registered nurse at Westgate Elementary is distressing and concerning. The Board and Administration care deeply about the safety and well-being of our students, families, and staff in our community. The action we took at today's meeting is not something we take lightly. Our administration and legal team have provided the Board with evidence of egregious conduct, violation of school policies, and willful insubordination, leading to today's recommendation for termination of employment. There is also an ongoing police investigation. We take our responsibility seriously to do our part to keep our school environment safe. Our Administration is working with the Cook County Department of Public Health and the Illinois State Board of Education to review and enhance our policies, and oversight of student medication management. "
